School Bus Rider Information for 2018 -19

Eligible Rider

Students whose **primary residence** is more than 1 mile (elementary) or 1.5 miles (middle or high school) walk distance from school are **eligible** for school bus transportation. Eligibility walk distances are established by state law.

Bus Stop Assignment

Each eligible rider may be assigned a school bus stop for both pick up and drop off. The two stops could be at different locations. For more information on bus stops, go to www.salemkeizer.org/departments/transportation and click on the FAQ link.

Alternate Address for Pick Up/Drop Off - (day care, relative, work, etc.)

Your student may be served at an alternate pick-up and/or drop-off address if:

1. Your student's primary residence is eligible for transportation (see above), AND
2. The alternate address is in the eligible area.

If both items are not true, your student **may** still be eligible for the requested service at the alternate address depending on available seating on the bus run serving the alternate address. Once assigned, the alternate address will be the primary address for service for your student (pick up, drop off, or both if an alternate address is requested for both).

Rules of Riding the School Bus

Riding the school bus is a privilege. Riders must follow all the rules of conduct, which can be picked up at any school or found online at www.salemkeizer.org/system/files/JCE-R.pdf.

Additional Information

Authorized riders may not invite others to ride on the bus with them.

Elementary student boarding procedures: On the run to school, bus drivers may check students against a roster of registered riders as they board. Students not on the roster will still be allowed to ride to school. Once they arrive, they must go to the office to get registration paperwork and an emergency bus pass in order to ride home. Each school will monitor their registered riders for the run home.

Secondary student boarding procedures: Students who have been authorized to ride will have a security sticker attached to their ID/ASB card. If a student has lost or forgets their card, they will be allowed to board the bus in the morning and will be taken to school. When they arrive at school they must go to the office and get an emergency bus pass in order to ride home.
