5. Major Exposure Reduction Activities

Salem-Keizer Public Schools has not completed any major activities that resulted in reduced risk of exposure to hazardous materials since the last report.

We have, however, done some things related to ensuring that we do not have hazardous exposures.

- **Radon** - We have 8 schools with radon mitigation systems, for which we do regular testing. All schools' radon levels are below EPA's Action Level of 4.0 picoCuries/Liter.
 - Candalaria Elementary School
 - Cummings Elementary School
 - Liberty Elementary School
 - Schirle Elementary School
 - South Salem High
 - Sprague High School
 - Straub Middle School
 - West Salem High School
- **Asbestos** – All asbestos containing materials are properly managed. Therefore, there is not a risk of exposure.
